



## Who can I contact for assistance?

---

## How is the grant designed?

---

There are currently three options for the Public Health System Improvement project application:

1. A monetary grant that will provide funding to the awardee for the completion of a community health assessment, community health improvement plan, organizational strategic plan, quality improvement plan, workforce development plan, or performance management system;
2. A monetary grant that will provide funding for the implementation of a health improvement program (or expansion of an existing one), implementation of a health improvement priority as identified in the community health improvement plan, implementation of an organizational development objective as identified in the health department's strategic plan, or the initiation / implementation of another health department project (preferably a PHAB-required process, such as the creation of a brand strategy, etc.);
3. A non-monetary grant that will provide direct one-on-one mentoring and technical assistance to the awardee from a subject matter expert in projects such as building community collaboration, PHAB accreditation management, Board of Health development, and more.

If awarded, a workplan and budget will be required as part of your grant project. Regular progress reviews and a final report are required as part of the task order.

## Who is funding these grant opportunities?

---

Funding for these opportunities is being provided by the Centers for Disease Control and Prevention (CDC) Preventive Health and Health Services Block Grant and a grant awarded by the Montana Healthcare Foundation (MTHCF).

## What supporting documentation do I need & where do I apply?

---

A letter of support from your agency's leadership and a proposed budget (for monetary grants) are required as part of the application. The application and more information is available [here](#).

## When does the application open? How long is the grant opportunity?

---

Applications will be accepted starting in May 2021 and will be accepted on an on-going basis (or until funding for the project has been depleted). Most projects are awarded for a one-year period; however, these opportunities are intended to be flexible in order to meet the needs of local and Tribal health departments across the state. Please contact [Kerry Pride](#) if you would like to discuss your health department's situation and determine what the best option would be. All projects and final reports must be submitted by July 2023.

## Can we apply with a neighboring jurisdiction(s)?

---

Applicants can include a single health department or multiple health departments. If more than one health department is applying, a Memorandum of Understanding (MOU) must exist among the jurisdictions for this funding opportunity.

## Who reviews my application?

---

Applications are reviewed by three independent persons at PHSD. The reviewers use a standardized grading rubric. If you would like to see the scoring rubric, please email [Kerry Pride](#).

## What are the benefits of participating in this grant?

---

There are many tangible benefits to completing the CHA, CHIP, and organizational strategic plan. Some of these benefits include:

- Creating lasting relationships with community members, healthcare providers, and stakeholders
- Identifying strengths and opportunities for improvement
- Setting priorities for your health department
- Addressing long-standing community concerns
- Strengthening government transparency and accountability
- Improving the performance of your health department
- Developing quality improvement culture
- Develop the workforce development plan to improve the capabilities of staff
- Building a foundation to become a Public Health Accreditation Board (PHAB) accredited health department

## When will the grant awards be announced?

---

Successful applicants will be notified by email no later than two weeks after their application has been submitted.

## What are the expectations if the grant is awarded?

---

Each grant opportunity has deliverables and an activity report due every three months (or based on the project's timeline). Each deliverable is outlined in detail in the task orders.
